

DECLARATION OF CONSENT

Dear Mr Mustermann!

In order to provide prospective students with an insight into the activities of our students in the context of teaching, we (CAMPUS 02, University of Applied Sciences, Körblergasse 126, 8010 Graz, Austria) would like to publish images and video recordings on the web and on the social media channels of CAMPUS 02. These images and videos recordings are created and posted by the respective social media team as well as by CAMPUS 02 staff or commissioned third parties on the basis of your consent (Art 6 para 1 lit a or Art 49 para 1 lit a General Data Protection Regulation).

Images and video recordings published in this context will subsequently be processed by the respective social media channels used (Facebook, Instagram, YouTube, LinkedIn, TikTok) and, if necessary, transferred to countries outside the EU. Data transfer to the US or China cannot principally be ruled out (there is no adequacy decision by the European Commission in place for these countries). We would like to emphasise that we have no influence on the respective data processing of these providers and do not assume any responsibility for it.

The way in which these providers use images and video recordings for their own purposes, the extent to which activities are assigned to individual users, how long this data is stored and whether data is passed on to third parties is not conclusively and clearly stated and is unknown to us. Since the European Court of Justice ruling C-311/18, no adequate level of data protection can be guaranteed for data transfers to providers that are subject to US surveillance laws. This is primarily based on the far-reaching access powers of the US authorities and the lack of legal protection for EU citizens. With regard to TikTok, state access to personal data by the People's Republic of China cannot be ruled out. Here, too, no sufficient rights of defence for those affected can be attested and thus no adequate level of data protection can be guaranteed.
